Bill Hope-Jones and Peter Chitty Retire from Lym. Soc. Committee

End Of An Era as Society Founder and Treasurer Bow Out

At the recent AGM the Chairman Clive Sutton confirmed the end of an era in the history of the Society by announcing the resignation from the Committee of Bill Hope-Jones and Peter Chitty, two people who have done so much over many years on behalf of the Lymington Society.

The Chairman then went on to describe the events that led to the setting up of the Society by Bill Hope-Jones.

"I am told that in late 1945 Robert Hole 'ordered' Bill and Cecil Blatch

to lunch so as to get them involved with his idea of having a community centre in Lymington. There was a public meeting in March 1946 and Bill became a member of the foundation committee and later treasurer -- for 50

In addition to the Community Centre, Bill was involved in the founding of the Lymington Society and has been active in it ever since. I can say that during my time as Chairman he has regularly attended meetings and has made contributions which often put our parochial concerns into perspective.'

(Editor: The Committee wish to set out on the Society's behalf everyone's huge gratitude to Bill for the many years of service to the Society in so many capacities. A future edition will set out in more detail, the History of the Society and Bill's important Role in the Society's history.)

Chairman's Annual Report to the AGM

Clive Sutton' Address to the AGM at Lymington Community Centre Aril the 5th 2006

Welcome

Ladies and Gentlemen, can I welcome you all to this Annual General Meeting of the Lymington Society.

I am pleased to say that we are now settled into a regular pattern with our AGMs, holding them in March or early April.

New Social Programme

Thanks to the enthusiasm of our Committee Members and thanks to some prompting from the members at the last AGM, we have started to be able to involve our members more in social events. Later on in this meeting you will be hearing of a programme of further events and I believe the programme is being circulated

I hope those of you who were able to attend, enjoyed the party at Stanwell House Hotel in December and the Reception at the St Barbe Museum in January. The feedback from both was very positive. We were very pleased that several Town Councillors were able to come to the party in December.

Improved Newsletter

A landmark this year has been a production of an improved Newsletter which you received before Christmas. We are conscious that you have not yet had another one but we are working to produce this fairly shortly after this meeting.

I hope there will be between two and four Newsletters per year depending on the amount of material we have to report.

Consideration of Planning Applications

The Committee have held their regular monthly without a break. To miss a meeting means that we can miss Planning Applications and the time for making representations passes. I have to give personal thanks to Nick King and Derek Scheffer for watching the Planning Notices and the Council's Website like hawks to alert us to important planning applications.

Obviously most of the applications that come through are of a routine nature and we try not to get involved in issues which are only of interest to neighbours, unless those applications challenge an important point of planning principle.

However there are numerous applications at present which continue to try to push the boundaries of what the Society's Committee Members feel is acceptable and which if passed, would have the effect of significantly altering the character of the locality.

Development at Waterford Lane

You are all aware of those applications to which I am referring to. Examples this year have been the Waterford Lane application for dense housing in a very pleasant residen-

tial area of Lymington in Waterside. That application was refused but will return again in another form.

Bath Lodge Development

Similarly the application for redevelopment of the important site of Bath Lodge has also been refused and the developer's architects are seeking to have a meeting with the Society to discuss further proposals. I can say personally that I do not welcome meetings with developers where an application has been made and the purpose of the meeting is merely to persuade us to accept the application. I am much more interested in meetings where the plans have not been finalised and the purpose of the meeting is to discuss the sort of proposal which would not substantially harm the locality and which hopefully would enhance it.

Avenue Road/Buckland Road

Another important application to which the Committee responded by making representations at the public appeal, was the Avenue Road site on the corner of Buckland Road, which was refused by the Inspector and which is again being applied for in a different form.

Lymington's Changing Character Caused By Large Developments

I think the Committee were one of the first groups to express concern as to the changing character created by large developments in suburban roads. We are now starting to see the effects of the grants of those applications which the Committee resisted, but which were granted in any event. I expect you have all noticed the new developments in Avenue Road by the school entrance and on the other side of the road to it. We already have the large development at St. Andrews Lodge. The developers will soon be able to argue that further large-scale development will not be out of keeping with the character of the locality, because the locality has already changed.

Proposed Lymington Forum

During the course of the year your Committee proposed a Forum with other local bodies such as the Chamber of Commerce and the Town Council. The Town Council has not felt it possible to have an informal dialogue with the Lymington Society because they feel that they are restricted to a degree of formality in their relationships with other bodies due to their public position. That is understandable but we are able to talk personally to members of the Town Council and have very friendly personal contacts with them. We liaise where appropriate with the Chamber of Commerce.

Dialogue With the NFDC

The Committee has been able to have a constructive dialogue with the New Forest District Council planning officers and I can say that a very useful meeting was held with Chris Elliott, the Chief Planning Officer, a couple of months ago. That has given us as a Committee, several pointers as to particular representations that we can make, which hopefully will have a prospect of being well received by the Planning Department.

Summarising briefly what Chris Elliott told us, he described how the NFDC Planning Authority will be reduced by some of its Offi-

cers being seconded to the National Park. I am sure we will hear more of that later from Ted Johnson.

Lack of Proper Representation before Planning Applications are Made and at Planning Committee of NFDC

Of particular concern to the Society was the question of representations on planning matters. Committee Members have been very concerned as to the fact that in Council Planning Meetings time for representations on major planning matters such as the Webb Site and other decisions, having an important impact on Lymington, are given the same amount of time, a total of three minutes for all representations, as for an application for a small extension to a property.

Need for More Pre-Planning Consultation and Representations for Large Developments

Obviously a small extension is of importance to the applicant as a large development is to a developer, but what is distinguishes them is that the impact of a small development on the locality is likely to be very much less than a large development, and the question of the amount of time granted for making representation to the planning committee should be looked at from that perspective.

It seems that one difficulty with the planning process is that the developers take a view as to what is in their commercial interests, and at some considerable cost in architects and planning fees, they draw up a plan based on that. That is then rejected and it is then difficult for the developers to consider going back to the drawing board to approach the matter from a perspective which would be much more in keeping with the locality. That then leads to polarisation of views and possibly a planning appeal.

I think there are several developers who would be happy to be able to talk informally to the planners and also to amenity associations such as ours at an early stage in to establish local views on what is reasonable. The prime example of this has been the Webb Site where I think everyone now accepts that we would not be in the situation of the Council having had to approve what many people feel is an overdevelopment, if informal discussions had taken place with the developers as an earlier stage. Indeed the developers I believe would have been happy for this to happen.

The Webb's Site AGAIN ???

I am afraid we cannot seem to avoid the subject of the Old Chicken Factory Site in every AGM, no doubt for some time to come. The existing developers are I understand moving on and we await new developers and I hope that they will liaise with us if they are intending to change the plans. They do of course however have an existing permission for dense development which they can benefit from.

The Lymington Quay Bridge

I expect you have noted my crusade over the footbridge linking the Webb Site to the Town Quay, for which I do have the support of the Committee. This became public in our first Newsletter which put the negotiations with various parties into the public arena, which may or may not have been helpful. The question of the footbridge has all come about in the last year from the talk by Brian Avery at the last AGM. Following that meeting he drew up plans for a footbridge which then were put into a computer-generated picture and which have been published.

There are going to be problems with encroachment on the River, and opposition from adjoining owners, but the Society's intention is to act as a facilitator to explore the prospect of such a link as fully as possible by approaching all relevant parties. If it is not possible then the Society has done its best to achieve what it believes would be to the advantage of Lymington, and which will benefit the residents of that development. I can say that this is a something which the New Forest District Council Planning Officers want to see achieved.

The Future Planning of The Area North of the High Street

There are other sites where forward planning could be very useful such as the question of parking on the Tesco car park site and the issue of the whole of that area including the Old School Site.

The Retirement of Bill Hope-Jones and Peter Chitty

I have to deal with two important personal matters. The first is that you may have noticed that for the first time for many many years the meeting has not been formally introduced by Bill Hope-Jones. He has let it be known recently that he does not feel he can attend any further committee meetings or this AGM.

The second important announcement to make is that I have lost a personal battle. I have always persuaded him to withdraw them, but this time he has reminded me that when he joined the committee he managed to persuade some of the then more elderly members of the committee to resign so as to allow some new blood and ideas into it.

Alison Bolton does so many other things but it is a very good committee member always having a point of view and representing the matters involving the outlying villages and in particular the Forest. This will be more valuable as the National Park becomes a very prominent neighbour to Lymington. We shall know more in a moment as to whether it will be a threat or a benefit.

Don Mackenzie

Don Mackenzie is a very active member and has organised the revamped newsletter and some other personal initiatives. I am getting more and more feedback about people having first learnt about an important planning issue from a visit to the dentist. I hope one day all his pa-

tients will be members of the Lymington Society if only because they will not be able to say no at the crucial moment. In addition to the Newsletter, Don is closely involved in public responses to the Council on various consultations and in particular has taken the initiative to raise the issue of the Master's House at the Infirmary.

As you are probably aware by now, Don discovered that the Masters House had not been listed due to a bureaucratic mixup. It was scheduled for demolition. In fact it is one of the few surviving examples of a workhouse style of Victorian architecture left unchanged in the country. Although at the moment the Master's House may not look too prepossessing I hope in years to come it will be seen as an important piece of architecture which it was important to retain.

I think it will be said by the Health Authority that our intervention has led them to change their plans as a result of not being able to demolish it. I fear this is a conflict which is going to arise from time to time, but wearing our Society's hat we must do what is right over the preservation of buildings and the history and character of our Town.

Nick King

Nick King lives behind the High Street and is very conscious of the impact of inappropriate development in the burgage plots. Although he works in London he spends a lot of time researching planning issues, dealing with individual planning responses and keeping us up to date.

Derek Scheffer

Derek Sheffer comes from a similar situation in living behind the High Street and being concerned as to neighbouring development. He backs up Nick King on the planning side and I believe is able to keep his ear to the ground to pick up local views. I am particularly grateful for him agreeing to take over the Treasurership from Peter. If there have been any administrative hic-ups this year during the changeover I hope you will understand.

Nigel Seth Smith

Finally our new member this year is Nigel Seth-Smith who has accepted the duties of events organiser, which is something which has been sorely needed on our Committee. He has started off admirably organising the two functions in Christmas and January. There is also a Social Committee to assist Nigel in organising events.

As you see all our Committee Members have their strengths and particular duties. We still need someone to advise us with technical planning issues as I anticipate there will be occasions when developers will more frequently start to ask our opinion on proposed development schemes.

Planning Report

We're lobbying for better arrangements for representation at NFDC planning meetings, where speakers are arbitrarily restricted to 3 minute slots; and have asked whether the Society could be involved at an earlier stage with the planners and developers to ensure more suitable proposals for sites of significance, such as the Old School in Cannon Street.

We've continued the fight against poor planning decisions, focusing our efforts on overdevelopment or replacement of houses with flats, which would result in spoiling the character of our

It looks like we'll have another chance to influence a new developer and help secure a development worthy of this wonderful riverside site. What we've been working for all along is a less dense and more imaginative scheme that links the new development into the life of the town, not an isolated



second-home dormitory - this is what people who attended our Open Meeting wanted. Dr Mackenzie expressed our posi-25.02.2006 and Mr. Sutton has been championing the idea for a bridge linking the development to the town, an imaginative design by local architect Brian Avery.

'Housing Design, Density and Character' - Special Planning Guidance

We took part in December in NFDC's consultation on this important new planning measure, which aims to 'place design quality alongside density at the centre of policies on housing development'.

We agree that, in the right location, well designed higher density developments can 'improve the character and sense of identity of a place'. However, we fear that the process as outlined could simply serve as a prequalification service for developers, a way to qualify sites for higher density development at an early stage, before spending time and effort on detailed designs.

For example, the guidance recommends

that a developer should seek a pre-application discussion with their local planning authority on the basis of 'design aspirations and a basic concept plan to calculate building area, mass and thereby numbers of dwellings'. In other words, a developer need not submit a single architectural drawing or visual showing how a

development would look before participating

in a pre-application discussion that could qualify a site suitable for higher density development with an agreed number of dwellings.

We're all in favour of pre-application discussions that reduce the number of unrealistic planning applications but we want to make sure they consider the right issues and reflect the views of local people on how their town develops. In particular, we believe that when a development proposal puts them in conflict with each other, enhancing character should take precedence over higher density.

Lymington is a market town with a distinctive character that owes much to its unusual New Forest/Solent/Lymington River location. Its combination of sailing marinas, attractive riverside walks, country lanes and unusually intact Georgian town centre attracts high levels of inward investment and visitors. Any guidance should take as a starting point a requirement that development should enhance its distinctive character.

We have asked if we can take part in the more detailed stages of defining this potentially powerful planning tool.

The Nelson Exhibition

The second event of the Social Programme was also extremely well attended with over 40 members turning up at the St Barbe Museum to see the fantastic Nelson Exhibition. This exhibition featured paintings related to the life of



Nelson Boarding a Captured Ship November 1777

Nelson. As well as the paintings themselves, we were then treated to a fascinating talk by the museum's curator Steve Marshall.

Steve explained that you could tell when a painting was published by the number of medals worn in the picture. Painters who had previously painted a picture of Nelson from a sitting would constantly update the picture by adding more medals as Nelson's fame and importance

The cult of Nelson was so strong that many years after his death commemorative items were still being produced.

Throughout his career, even as a junior officer, Nelson would regularly send back reports to the newspapers of his exploits and was acutely aware of the need to keep himself in the public eye. An important exhibit in the exhibition was the famous Nore Drum. This drum which is actually owned by Lymington Town Council and is normally on display in the National Maritime Museum, was presented to local Lymington aristocrat and naval hero Sir Harold Burrard-

The drum commemorates the famous occasion when he was involved in putting down a mutiny at The Nore, a naval base in the Medway in May 1797 after which he was presented with the drum by a grateful Admiralty.

Painting with Scissors. Exhibition of Matisse's Iconic Cut-outs The final event to have taken place so far in this season's events took place again at The St. Barbe Museum where the Society had a Private View of the famous cutouts produced by Matisse in the 1950s

the growth of the urban conurbation of the South Coast had led to increasing pressures on the New Forest which were threatening to overwhelm it.

Following the formation of the New Forest Committee, pressure grew on Government which resulted in the creation of the first National Park in England since the 1950s and the only National Park in Southern England.

Following the formation of the Authority the last year has been spent finding premises to house the employees, finding suitable staff, setting up computer systems and all the normal structures required by such a body.

Currently the authority is housed in the old Efford Horticultural Institute offices until they acquire their own building in the Forest which is likely to be in Lyndhurst according to rumours.

Authority will not employ their own personnel to maintain the Forest but will rely on the Forestry Commission and The Verderers' Agisters for some of these services.

Mr. Johnson then touched on the many aspects of the New Forest which still lie under the control of locally elected Councils. These bodies however will now have to consult with the Authority before embarking on any major schemes

Following an interesting question and answer session between the Members and Mr Johnson, The Chairman Mr. Sutton closed a very successful meeting at 9.30 pm.
